



These are the three main parts:

- Registration at 1ClickFactory
- Passing the Software Solution Test
- Providing 10 customer evidences to Microsoft




Before registering your solution for testing, please make sure that:

- Your solution is prepared for the latest Microsoft Dynamics NAV 2018 version with the latest cumulative update applied


To begin your CfMD process, please follow these steps:

- 12.2. Other evidences could be over the past two years of customer licenses.
- 12.3. Account numbers of the references must be different
- 12.4. Collected evidences must be filled out and sent to Microsoft to dyncert@microsoft.com
